

New Congressional District Data – 16 Million People Would Lose Health Insurance From Medicaid, ACA Cuts

According to the nonpartisan Congressional Budget Office (CBO)'s most recent <u>analysis</u>, President Trump and Congressional Republicans' cuts to Medicaid and the Affordable Care Act (ACA) would result in 16 million people losing their health insurance by 2034. Using CBO's analysis released June 4 and other research, the Joint Economic Committee – Minority calculated new estimates of the number of people who would lose health insurance in each Congressional District.

Note: Part of the Committee's calculations comes from Congressional District data that does not fully reflect redistricting done in 2024, so estimates for North Carolina, Georgia, Louisiana, Alabama, and New York may not be an exact match. Values for people losing ACA coverage have been rounded for non-At Large districts.

Source: The Joint Economic Committee – Minority's state-by-state numbers were created by combining estimates from the nonpartisan Congressional Budget Office on the national total number of people who would lose insurance by 2034 with a range of state-level data on the number of people enrolled in Affordable Care Act plans, the total number of Medicaid enrollees in each state, and early analyses of how some Medicaid cuts in the bill would impact each state. The Joint Economic Committee – Minority may issue updated estimates based on changes to Congressional Republicans' legislative text and/or updated estimates from the Congressional Budget Office or other nonpartisan analyses.

To calculate the Congressional District data, the Committee's state totals are allocated to each Congressional District based on data provided by the House Budget Committee on the number of people in each District who are enrolled in Medicaid or in ACA Marketplace Plans. These estimates were sourced from the Regional Leadership Council and the Center on Budget and Policy Priorities. Due to redistricting in 2024, Congressional district data for North Carolina, Georgia, Louisiana, Alabama, and New York may not be an exact match.
