What you need to know

- The Bureau of Labor Statistics (BLS) reported that in January [the unemployment rate fell by 0.4 percentage point to 6.3%](#). However, the decline was driven, not by more hiring, but by the fact that 400K workers left the labor force and thus were not counted as being unemployed.
- [BLS found that 4.7 million Americans](#) “were prevented from looking for work due to the pandemic.”
- According to Moody’s Analytics, [President Biden’s economic rescue plan will bring 2021 real GDP growth to almost 8 percent](#) and the economy will add 7.5 million jobs.
- The Congressional Budget Office estimates that [the Raise the Wage Act of 2021 would lift almost 1 million people out of poverty](#).


Chart of the week

American workers continue to earn the federal minimum wage of \$7.25 or less in many industries. The situation is particularly bad in the leisure and hospitality sector, where more than one-third of workers earn the minimum wage and almost 70 percent earn less than the minimum wage.

Labor laws allow tipped workers to be paid a subminimum wage. Like a low minimum wage, this can hurt restaurant workers economically, [who are disproportionately women and people of color](#).

The Raise the Wage Act of 2021 would repeal the subminimum wage for tipped workers, which could help alleviate these wage gaps.
